CG SIX FOUR FOUR THREE DASH C ADVISED JUNE TWENTY NINE LAST THAT HE ASSISTED ONE CONNIE PITT OF PITT REALTY AGENCY, CHICAGO, ON THAT DATE IN ATTEMPTING TO COLLECT A DEBT OWED TO PITT, WHOSE TRUE NAME IS CORNELIUS PITT, THIRTY NINE SOUTH LA SALLE, CHICAGO, BY TWO INDIVIDUALS CONNECTED WITH THE CHICAGO ART GALLERIES, SIX HUNDRED SOUTH CHICAGO AVE., CHICAGO. PHONE DIRECTORY REFLECTS THIS TO BE MICHIGAN ART GALLERIES AT THAT ADDRESS. THESE TWO INDIVIDUALS GAVE A CHECK IN THE AMOUNT OF FIVE HUNDRED DOLLARS, CLAIMING THAT HE COULD NOT COME UP WITH ANY

MORE AT THE TIME. WHEN PRESSURED BY THE INFORMANT AS TO THE REASON, BOTH INDIVIDUALS CLAIMED THAT THEY HAD RECENTLY BEEN GIVEN FIFTY THOUSAND DOLLARS BY SAM DE STEFANO ON A QUOTE JUICE END QUOTE OR LOAN SHARK BASIS, AT AN INTEREST RATE OF FIVE PER CENT PER WEEK OR PER MONTH. ACCORDING TO INFORMANT, MONEY GIVEN TO THESE PERSONS BY DE STEFANO WAS ACTUALLY GIANCANA/S, AND DE STEFANO IS ACTING
