A form was returned from the Identification Division of the FBI stamped 1/10/58 "no arrest record,"() A duplicate work permit card was issued to CECLOA on 6/25/58, at which time he gave a local address of the New Frontier Hotel and listed employment as box man at the Stardust Hotel. TEETER advised that in the event it was ever necessary to surveil any of the MC GUIRE Sisters, care should be taken, inasmuch as all three of the sisters can read lips at any distance they can see. He said this ability to read lips has been developed over a number of years and he considers all three of the girls to be experts. TEETER stated he was not attempting to obtain any information relative to any possible surveillance but was merely furnishing information since he desired to cooperate with the Bureau. No indication was given to TEETER that surveillance had been placed on PHYLISS MC GUIRE concerning the Green Gables Ranch. W

TEETER stated that PHYLISS believed she was under surveillance by the FBI at all times and that obviously the thought had been inspired by subject.

In this regard, it is noted that PCI [\_\_\_\_\_] (Protect Identity) advised SA WILLIAM R. SWOPE on 6/26/61 that JOE PIGNATELLO thought that he was under constant surveillance and had made the remark that he changed automobiles three or four times a day to evade surveillance. It is noted no fisure has been maintained on PIGNATELLO in order that there be no possibility of interferring with the present investigation on subject. OTHER 4

A fisure of PHYLISS MC GUIRE on the night of 6/16/61 reflected she left the Desert Inn Hotel in a 1961 Cadillac Convertigle, Nevada license C 63414. She drove to the Green Gables Ranch Whicheisnlocatedeon Pecos Road approximately ½ mile south of Flamingo Road in Paradise Valley near Las Vegas. It is noted that the Green Gables Ranch is in a fairly isolated desert area and that a fisure on the vicinity except from a fixed observation point is not practical. The Green Gables Ranch is presently under a five year lease to a Mrs. GAY ROBERT, 413 Las Vegas Boulevard South. Discreet inquiry in Las Vegas reflects Mrs. ROBERTS operates the Personality Center (Massage Center) and that she would probably not be too responsible in her actions. Further discreet inquiry reflected that Mr. and Mrs. SETH ANTHONY reside on the ranch and occupy the position as caretakers. W

Contact was made on 6/17/61 with Mr. and Mrs, SETH ANTHONY away from the ranch. It was determined that SETH ANTHONY is a First Lieutenant in the United States Air Force and is presently stationed at Nellis Air Force Base near Las Vegas. The ANTHONYs described the ranch as follows:
