WEINER; ALLEN M. GOODMAN; MISCELLANEOUS - INFORMATION CONCERNING (ACCOUNTING AND FRAUD SECTION)," 62:Chicago, Bufile 62-7986, 62 file 62-6020. Results of review of these records as related to these cases should be reported in the case to which the information relates. It is felt that these records may be of assistance during the interviews with Charles W. Bray and that Bray may be able to refresh his memory from these records concerning pertinent transactions in these cases.

These records should be retained by the Chicago Office until further advice is received from the Criminal Division as to their ultimate disposition.

On September 11, 1963 Attorneys Robert D. Peloquin and Edward F. Harrington obtained various records of Homer Bray Services, Ltd. of Canada, Jonsphillips, Ltd. of Canada, and Intercontinental Surety and Casualty Company of Panama. The records were received from John Ruddy, Town Court, Apartment 65, Nassau, Bahamas. Mr. Ruddy informed that he was holding the records for Charles Bray but did not desire to give the records to Bray in that he knew the Federal Government would be interested in them. Charles Bray had previously given consent to Messrs. Peloquin and Harrington to obtain said records. I intend to forward the records to the Chicago office of your Bureau in that they may be of use to your Agents in future interviews of Charles Bray and in any analysis concerning captioned matters.
