As noted in rerep HAZIDAKIS is deeply involved in gambling activities of the MANNARINO organization and it is felt that the background information requested in the enclosed memorandum, if obtained discreetly, would be most helpful when interviewing HAZIDAKIS at a later date for the purpose of developing him as an informant. Consequently the Bureau is asked to have the investigation conducted through proper liaison in Greece. (S) (u)

The source referred to in the enclosed memorandum is [redacted], an admitted New Kensington, Pa. numbers writer and long time acquaintance of MIKE GEORGE HAZIDAKIS.
