ROSSELLI still residing at his Los Angeles apartment.

GEORGE SEEDMAN, Rowe Vending Company representative, interviewed 2/21/63 and though he was cooperative concerning vending machine matters he claimed he was not acquainted with ROSSELLI and had never heard of him. It is recalled that in latter part of 1962, LA 4268-C told ROSSELLI that he, informant, might go to work for SEEDMAN and ROSSELLI wanted informant to find out all about SEEDMAN's operations in the vending machine line. Both ROSSELLI and FRIEDMAN are Friar's Club members but it is not known if SEEDMAN does, in fact, know ROSSELLI.

On 1/22/63 toll call was made from room occupied by MAHRICE H. FRIEDMAN and MICHAEL C. HELLERMAN at Beverly Hilton Hotel, Beverly Hills, to telephone number 382-5222 in Las Vegas, Nevada. Las Vegas advised this number listed to WILLIAM G. COULTHARD, an attorney who is former FBI agent and who has been very friendly and cooperative with Las Vegas Office in past. Las Vegas being requested interview COULTHARD.

Investigation conducted 2/21/63 revealed that the present owners of the 1962 Chevrolet, which ROSSELLI owned and reportedly gave to a girl friend, purchased this car in the latter part of 1962 from Lee White Rambler Dealers in Downey, California, and that Lee White Company purchased it in April, 1962, from Brand Motors in Los Angeles. It is noted that ROSSELLI purchased his present car, a 1963 Ford T-Bird, from Brand Motors in December, 1962.
