LA 4268-C advised ROSSELLI at Friars Club, Beverly Hills, afternoon 1/21/63 playing cards but was not observed at club by informant on 1/22/63. Informant advised Friars Club having big party for FRANK SINATRA & SAMMY DAVIS, JR. (well known entertainers) evening 1/22/63. Tickets cost \$50 but scalpers are asking \$200. Proceeds reportedly go to Friars Club Charity Foundation.

LA 4396-C advised ROSSELLI indicated he would attend party at Friars Club tonight, possibly with MAURICE H. FRIEDMAN, JOSEPH I. BREEN, JR. and "LOUIS and wife" (possibly LOUIS J. LEDERER).

According to LA 4396-C, ROSSELLI will travel to Las Vegas on 1/23/63 to attend a party at Convention Hall in Las Vegas on evening of 1/23/63. ROSSELLI indicated dinner may be to honor HARLEY HARMON (believed to be a Clark County Commissioner). ROSSELLI asked individual named JOE (believed to be JOSEPH I. BREEN, JR.) to go to Las Vegas with him to attend this party and hinted that HARMON could probably get BREEN a job in a bank.

ROSSELLI said he had been (in Las Vegas) trying to buy some land; that he could have bought it in the past for \$398,000 but that now it is selling for over \$1,000,000.
