LA 4396-C\* has received no information that ROSELLI has been at his Los Angeles apartment during the past week.

LA 4268-C has not observed ROSELLI at the Friars Club, Beverly Hills, Calif., during the past week. It is noted that ROSELLI nearly always frequents the Friars Club when in Los Angeles.

As of 12/26/62, ROSELLI was residing at the Desert Inn Hotel in Las Vegas, Nevada, and investigation is continuing there by the Las Vegas Office.

Re Bulet dated 12/28/62 instructed that investigation be conducted by the New York Office regarding JUDITH E. CAMPBELL.
