LA 4396C\* furnished information that during the evening of December 8 and 9, 1962, ROSSELLI told a girl named SHARON (SHARON ANN JOHNSON) that he was leaving the next day, but he did not state where he was going.

On 12/17/62 ALLAN M. DUNCAN, Business Manager, Sansum Medical Clinic, Santa Barbara, California, advised that ROSSELLI was a patient at the Cottage Hospital, Santa Barbara, for a complete physical check up from December 9, 1962, until December 12, 1962.

LA 4268 advised that on Friday, 12/14/62, ROSSELLI was at the Friar's Club, Beverly Hills, California, during the afternoon and was still there shortly after 5:00 pm when informant left. Informant learned that the Friar's Club was charging ROSSELLI's account for a long distance call he had made about noon that day to Chicago, Illinois, to telephone number 828345. Informant said only six digits were mentioned in this number. *oc*

MAURICE H. FRIEDMAN, part owner of New Frontier Hotel, Las Vegas, and a close friend of ROSSELLI was with ROSSELLI at the Friar's Club.
