On 11/20/68 British Security Service, MI-5, advised that they have now obtained the travel records of SUSAN FRANK. She arrived in England at London Airport from Paris on 8/8/68 and left for an undisclosed destination on 8/15/68. Her attitude to the British Immigration Officer on her arrival was described as evasive. She did not come to the attention of MI-5 in any security connection and no record has been located of any arrival or departure of RICHARD FRANK. When she arrived she stated she was to stay at the Cadogan Hotel, Sloane Street, London, S.W. 1. (S)
