Inquiry at the Georges V Hotel, Paris, France, was made regarding Joseph Mandrake, but he is unknown at this hotel. (c)

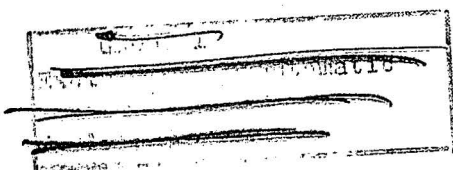
T-1 advised that they have no information whatever regarding "Madwoman." (c)
