

### NY 100-107383

NY T-l advised on June 29, 1959, that SUSAN WARREN, also known as Susan Frank, had been nominated to the Latin American Committee of the International Affairs and Peace Commission, Communist Party, United States of America (CPUSA).

NY T-l advised on August 21, 1959, that the CP in China wanted an American writer to work on the "Peking Review" for at least two years, and the CP of China had heard that SUSAN WARREN is a likely candidate for this position.

It is to be noted that the "Peking Review" is a publication published in Peking, China, for dissemination outside of China.

NY T-l advised that SUE WARREN did not want to spend two years in China, but was willing tostay for one and was planning to leave in October, 1959.

NY T-1 advised that SUE WARREN was well trained in Far Eastern affairs.

NY T-2 advised on August 8, 1961, that early in May, 1961, the subject and his wife were in Moscow having gone there recently from a trip to China.

NY T-3 advised on May 3,1967, that the subject is employed as a free-lance assistant director working out of the Director's Guild of America, 59 East 34th Street, New York, New York.

NY T-3 advised on July 15, 1967, that the subject had recently been in Cleveland doing a television job at the Republic Steel Company.

#### Travel

NY T-4, a confidential source abroad, advised on May 18, 1967, that the subject lived in Paris, France, in a hotel from May 17 to 18, 1964. He lived with his wife, MILDRED SUSAN HEILIGMAN, Whorn November 8, 1913, at New York in a hotel in Paris December 27 to 28, 1966.

During the subject's stay in Paris, he was in contact with OLGA PRIMUZ nee HORSTIG born October 11, 1912, at Belgrade, Yugoslavia, who is an artist's representative with her husball, VJEKOSLAW PRIMUZ, born December 18, 1906, at Pozin, Yugoslatia. They have an office at 76 Avenue Champs Elysees, Paris. VJEKOSLAV PRIMUZ is described by NY T-4 as an ex-diplomat of the Legation of Yugoslavia at Paris, and he was suspected by the source in 1948, to be a member of the Yugoslavian Intelligence. He was in that period in contact with the Yugoslav Embassy in Paris. He was a member of the Secretariat du Parti-Paysan Croati (The Secretariat of the Croatian Peasant Party) and Vice-President of the Mouvement Federaliste Croate (Croatian Federalist Movement in France).

The subject was also reported in contact with REGIS BERGERON, born April 13, 1923, at Ecrennes, France. BERGERON is Editor and Chief of "L'Humanite Nouvelle", a Marxist-Leninist newspaper. BERGERON also represents the French Marxist-Leninist Communist Movement, a pro-Chinese organization located at 40 Boulevard Magenta, Paris.

NY T-5 advised on February 14, 1967, that on January 26, 1967, the subject and his wife told him that they had recently been on a trip to North Africa and Europe. NY T-5 said that they described to him tourist sites in Morocco and a visit to an art gallery in Paris. (%(4)

NY T-6 advised that his records indicate that on December 18, 1966, the subject was at the Colony Sporting Club, London, England, and he was also in England on December 19, 1966. The records of NY T-6 also indicate that the subject was at the Royal Garden Hotel in London, England, on January 14, 1967.

On January 2, 1967, the subject was at anhotel in Tangiers, Morrocco.

NY T-6 advised that some time during late 1966 or early 1967, the subject was at the Auberge des Bonheurs, 280 Rue St. Honore, Paris, France.

NY T-6 advised that on January 3, 1967, the subject was at a hotel in Casablanca, Morocco, and on January 9, 1967, he was at the Hotel Mamounia Avenue Bal Djadi, Marrakech.
