By letter dated 3/14/67, classified CONFIDENTIAL, British Security Service, MI-5, advised that RICHARD CYRIL FRANK paid another visit to England from January 10 to 14, 1967. He arrived at London Airport from Paris and left London Airport for New York. According to MI-5, there is no trace of SUSAN FRANK having been in England since her departure on 12/25/66, when both FRANKS left for Paris. (c)
