The Prefecture of Police, the Renseignements Généraux (General Investigative Section), Sûreté Nationale (RGSN), and the Service de Documentation Extérieure et de Contre-Espionnage (SDECE), French foreign intelligence and counterespionage service, were promptly alerted on 6-28-66 on the receipt of reBucab as to the subject's visit to Paris. These agencies were requested to furnish us any information which they may be able to obtain regarding his activities here (S)

No information has been received from these sources. We will remain alert and advise the Bureau. (S)
