on 9/2/64, LA 4448-C-TE furnished information that within the past week he had attended a rosary for a friend of his and observed, also attending the rosary, a man he knew by sight, but whose name he could not recall. Eventually this man came over and talked to informant and one of the first questions he asked informant was how was JOHN (ROSSELLI). Informant replied in general that he does not see ROSSELLI frequently. During the course of the conversation informant asked this individual for his business card which reflected his name as JOHN R. TARANTINO a real estate broker who is affiliated with the San Fernando Valley Investment Company, 10610 Magnolia Boulevard, North Hollywood, California, telephone numbers PO 1-0374 and TR 7-4065.

A current telephone directory reflects JOHN R. TARANTINO resides at 6239 Orion Avenue, Van Nuys, California, where he has telephone number 785-4910.

Informant advised that TARANTINO is about six years older than ROSSELLI, that he was raised and went to school in Boston, and was acquainted with ROSSELLI and ROSSELLI's family in Boston and would, without a doubt, know ROSSELLI under his current name JOHN ROSSELLI, and under the name of FILIPPO SACCO.

The indices of the Los Angeles Office contained no references identifiable with JOHN R. TARANTINO.

On 9/3/64, information was obtained from the records of the Registrar of Voters, Los Angeles County, indicating that JOHN R. TARANTINO, 6239 Orion Avenue, Van Nuys, California, registered as a voter on 9/19/48, to reflect a change of address from 1535 Allesandro, Los Angeles; that he is 5'8" tall, a real estate broker by occupation and was born in Italy. He was naturalized in Los Angeles, California, by Decree of Court on 3/1/35.
