Source advised that ROSSELLI does not look well physically and on July 30, 1964, arrived at the club at about 5: 35 p.m. in a very intoxicated condition. He asked IRVING J. LEFF, who was playing pool, to drive him home. LEFF is a stockholder in the Hotel Last Frontier Corp. and resides at the same apartment house as does ROSSELLI. LEFF _ told ROSSELLI to sit down and wait until LEFF finished his game of pool.
