Re Los Angeles radiogram to Bureau dated 6/23/64 requesting Bureau advise Legat Rome to hold in abeyance investigation regarding PHILLIPO SACCO requested in Los Angeles airtel to Bureau dated 6/1/64.

Enclosed herewith are six copies of a revised letterhead memorandum concerning the birth data of PHILLIP SACCO, aka. Philip or Filippo Sacco and his parents.

The confidential source mentioned in the second paragraph of the first page of the letterhead memorandum is LA 4448-C-TE.

It is requested that the legal attache at Rome, Italy, conduct the following investigation:

1. Review appropriate public records at Caserta, Italy for the purpose of verifying the birth of PHILLIP SACCO, aka., in that city on or about 7/4/05, and to obtain a certified copy (or the equivalent) of the birth record.

2. Endeavor to determine when and on what boat PHILLIP SACCO and his parents left Italy for the United States and any information as to where they intended to go in the United States and at what U. S. Port they entered.
