SHARON SHERMAN, switchboard operator at the apartment where ROSSELLI resides, advised on 7/17/64 that ROSSELLI had not been residing at his apartment during the previous week and that she had not seen him this week until the morning of 7/17/64. Source did not know if KATHY HORDEN, whom ROSSELLI refers to as "Mrs. ROSSELLI," is currently at the apartment. SHERMAN advised that on the morning of 7/17/64 a "Mr. LUDWICK" (Ph.) called ROSSELLI. She said that last week, while ROSSELLI was gone, the office of JAMES CANTILLON endeavored to contact ROSSELLI and a man left a message for ROSSELLI to call "BENJAMIN" at the club. "BENJAMIN" may possibly be BEN TEITELBAUM who is frequently contacted by ROSSELLI at the Friars Club in Beverly Hills, California.

Examination of the records of the Marriage License Bureau for the City and County of Los Angeles, beginning 1/1/64, failed to disclose a license issued to either ROSSELLI or to KATHLEEN HORDEN, aka.

On 7/15/64 LA 4268-C was at the Friars Club but did not see ROSSELLI there. Source advised that on 7/13/64 he was at JERRY ROTHSCHILD's Barber Shop in Beverly Hills. A man sitting next to source, whose name is Dr. MASON, began conversing with source. During the conversation, and at no prompting from the source, Dr. MASON related that last month he met in Las Vegas with JOHN ROSELLI, MAURICE H. FRIEDMAN and
