if ROTH cannot reach ROSSELLI, he will ask to be switched to the apartment of IRVING J. LEFF (part owner of the Hotel Last Frontier Corporation).

Examination of the "Emanuel Rothman, Trustee Account" at the Union Bank, which account has been used in the past by ROSSELLI's accountant, EMANUEL ROTHMAN, to handle funds for ROSSELLI, reflected that during the month of June, 1964, one deposit of \$1,000 was made to the account. On 6/1/64 a check for \$615 was drawn payable to Glen Tower Apartment. On 6/4/64 a check for \$2,500 was drawn payable to Hayden-Stone, Inc. (stockbrokers). On June 15, 1964, a check for \$1,000 payable to JOHN ROSSELLI was deposited to ROSSELLI's account at the Fidelity Bank, Beverly Hills, California.

Information has been previously set out that in March, 1964, ROSSELLI deposited to the above account a check for \$5000 drawn on the account of INES CHAPMAN of Beverly Hills, California, and that the check bore a notation that it was for "2000 Pacific Vitamin."

On 7/2/64 information was obtained from Pacific Vitamins, Inc., North Hollywood, California, that the stock records of this company for September, 1963, reflect that "JOHN ROSELLI," 1251 North Crescent Heights Boulevard, Los Angeles, was then the owner of 2000 shares of stock in the company. Mr. DAVID VICKTER, the owner of the company, stated that the City National Bank, Beverly Hills, California, act as transfer agents for this stock and would have a record of any sale of this stock by ROSSELLI and the name of the purchaser. VICKTER said that he did not know that ROSSELLI owned the 2000 shares. He said that he knows ROSSELLI through association at the Friars Club, but is not closely acquainted with him. He said he has had no business ventures with ROSSELLI and added that he does not know where ROSSELLI gets his money as he apparently does not have any employment. He then added that ROSSELLI must have some interests in Las Vegas, but he, VICKTER, has no knowledge of what these interests might be.

On 7/1/64 LA 4448-C-TE advised that about a week ago JOHN ROSSELLI "gave" a birthday party at La Rue Restaurant
