## LA 92-113C

On Wednesday, 6/24/64, ROSSELLI arrived at the Friar's Club at about 4:30 PM and left shortly thereafter. He returned shortly before 6:00 PM at which time he was very intoxicated and was talking in a loud voice. He invited IRVING J. LEFF to have dinner with him and told LEFF that his "wife" was cooking dinner that evening! LEFF declined the invitation, and ROSSELLI was still at the Friar's Club at 6:15 PM.

On 6/24/64 PCI, advised that in the latter part of May, 1964, probably around the 25th or 26th, ROSSELLI and his girl friend, KATHY, and JAMES P. CANTILLON and his wife had dinner at Dino's, a Sunset Strip restaurant and bar, and that they were accompanied by an attorney from <u>Washington, D.C.</u>, by the name of ED MORGAN. She described MORGAN as a tall, good looking man with dark, partly gray hair. OTHER 4

It is believed that this is the same ED MORGAN, Attorney, who has on occasion been retained by BELDON KATLEMAN, part owner of the Hotel Last Frontier Corporation.

LA 4268-C advised on 6/26/64 that ROSSELLI was present at the Friar's Club on the afternoon of 6/25/64.
