Captioned anti-Castro organization has previously been
involved in attempts to bomb Cuba. [ReMMairtel 1-14-65 advised MIRR
planning bombing raid on Cuba for sometime after 1-17-65. This
data was provided by MM 639-S who was asked to fly mission but
who would be detained by Customs before taking off with bombs.] ^{DO (u)}
Pertinent information in this airtel has been disseminated to intere-
sted agencies. Possibility exists MIRR gave press release for
propaganda and that no air or sea operations were conducted. If
there is any substance to MIRR claims, consideration will be given
to presenting facts to Department, if warranted, in line with our
established policy for determination as to whether full neutrality
investigation is desired.

For the information of the Bureau, MM 639-S said he was asked by ORLANDO BOSCH, head of the MIRR, to fly a bombing mission against Cuba. BOSCH gave the informant \$60.00 expense money to locate a suitable airplane to rent. (X)(U)

U. S. Customs, Miami, was immediately notified. Customs requested they be advised as to the identity of the plane, when it is rented, and that agency would then

maintain constant surveillance of this plane. When the plane picks up the bombs to go on a raid against Cuba, Customs then will seize the plane, all articles of war, and the vehicles at the scene. Customs said no arrest will be made, and all persons involved will be interviewed.

Miami Office feels MM 639-S will not be compromised with the Cubans or Customs, and there is no danger for the informant in participating. (X)(U)

Miami Office feels that the informant, in agreeing to fly the bombing mission, and being temporarily detained by U. S. Customs, will solidify the informant's position with BOSCH to the point of participating in future missions and possibly gaining knowledge of BOSCH's extortion activities. (X)(U)

This matter is being closely followed with the informant and U. S. Customs, and the Bureau will be kept advised.
