FGJ INQUIRING INTO MANNARINO ACTIVITIES IS IN RECESS UNTIL
JANUARY THREE NEXT. TO DATE, NO WITNESS HAVING PERTINENT INFOR-
MATION HAS BEEN COOPERATIVE. ON DECEMBER NINETEEN INSTANT, PG
SIX ONE FIVE DASH C, WHO HAS BEEN MOST PRODUCTIVE INFORMANT IN
THESE CASES, ADVISED HE THOUGHT IRS RAID ON MANNARINO HORSE ROOM
DASH GAMBLING CASINO IN NEW KENSINGTON, PA., ON AUG. TWENTYFOUR

DOLLAR KICKBACK FROM EACH. THIS INFORMATION DISSEMINATED LOCALLY
TO IRS. BOTH SUBJECTS ^{DEC 62} SHOULD BE CONSIDERED A AND D.
