ONE LAST, PG SIX ONE TWO - C AND PCI [] WERE AMONG
THE WITNESSES WHO APPEARED BEFORE THE FGJ IN PGH., WHICH DEPT.
ATTY. WILLIAM KEHOE IS CONDUCTING TO INQUIRE INTO THE ACTIVITIES
OF SUBJECTS. ON FEB. TWO, INSTANT, PCI [] ADVISED SA THOMAS
G. FORSYTH THAT HE WAS VERY UPSET BECAUSE HE FELT DA KEHOE WAS
TRYING TO QUOTE CRUCIFY UNQUOTE HIM BY ASKING QUESTIONS HE FELT WERE
DESIGNED TO TRAP HIM INTO ADMISSIONS AGAINST INTEREST INSTEAD OF
ASKING QUESTIONS CONCERNING SUBJECTS. HE ADDED THAT DA KEHOE-S
QUESTIONS ALMOST WHOLLY CONCERNED MATTERS UPON WHICH HE HAD
PREVIOUSLY FURNISHED INFORMATION TO SA FORSYTH WHICH LEAD HIM TO
BELIEVE SA FORSYTH HAD VIOLATED HIS CONFIDENCE AND DIVULGED HIS
IDENTITY TO KEHOE. PCI SAID HE WAS NOT GOING TO FURNISH INFORMATION
TO THE FGJ WHICH WOULD RESULT IN HIS BEING CALLED LATER AS A
WITNESS AGAINST SUBJECTS BECAUSE HE WOULD RATHER QUOTE GO TO JAIL

THAN BE DEAD OR HAVE SOMETHING HAPPEN TO MY FAMILY UNQUOTE. HE SAID THIS WAS THE GENERAL FEELING AMONG PEOPLE CONNECTED IN ANY WAY WITH SUBJECTS AND THAT HE WAS CERTAIN NOBODY OF ANY SIGNIFICANCE WAS GOING TO COME FORWARD WITH PERTINENT INFORMATION DUE TO FEAR OF SUBJECTS. PCI SAID HE FELT THE ENTIRE FGJ INQUIRY WAS A WASTE OF TIME AND THAT IT WOULD NOT INDICT SUBJECTS OR ANY OF THE IMPORTANT MEMBERS OF THEIR GANG BUT WOULD HAVE TO SETTLE FOR UNDERLINGS. PCI WAS ADVISED THAT SA FORSYTH HAS NOT DIVULGED HIS IDENTITY TO ANYONE AND HE REPLIED THAT KEHOE MUST HAVE GUESSED HIS IDENTITY. BASED UPON PERIODIC CONVERSATIONS WITH DA KEHOE, IT IS THE OPINION OF SA FORSYTH THAT KEHOE HAS STUDIED PG REPORTS CONCERNING SUBJECTS AND, AFTER CONSULTING WITH IRS AGENTS FAMILIAR WITH NEW KENSINGTON, PA., RACKETEERING ACTIVITIES, HAS DEDUCED THAT THE SYMBOL NUMBER USED IS IDENTICAL WITH PCI [REDACTED]. PCI WAS ASSURED THAT DUE PRECAUTION HAD BEEN TAKEN TO PROTECT HIS IDENTITY. AT THE CONCLUSION OF THE INTERVIEW, PCI WAS CALM AND REITERATED HIS DESIRE TO ASSIST THE BUREAU IN ANY WAY POSSIBLE. IN ADDITION, PCI STATED THAT GAMBLERS IN NEW KENSINGTON DO NOT
