This report has been delayed due to the preoccupation of the preparing Special Agent with important investigative aspects of this and related cases. However, pertinent information has been furnished to the Bureau and interested offices as received by appropriate communications.

Information in this report of possible value to the Internal Revenue Service has been furnished orally to Special Agent JACK SCHWARTZ, Intelligence Division, Internal Revenue Service, Pittsburgh, who is conducting the investigation of subject for his Service.

By letter 1/3/62, Pittsburgh Office advised the Bureau of the fact that all informants and sources familiar with any phases of the activities of the MANNARINOS had agreed that the IRS raid in New Kensington, Pa., on 8/24/61, the Westmoreland County raid of 9/17/61, the FGJ inquiry in Pittsburgh, and the election of reform candidates for the New Kensington city administration had all combined to make an information vacuum in that city, due to drastically curtailed gambling and the resultant inactivity of the MANNARINOS and their associates-employees.

INFORMANTS

Except in one instance, the T symbols utilized in this report will be the same, where applicable, as those used in previous reports back to, and including, that of 7/28/61. In the case of PCI ______ who has been PG T-25 in prior reports, recent conversations with Departmental Attorneys WILLIAM KEHOE and JOHN MULLANEY have caused SA FORSYTH to believe that they have guessed his identity, and for this reason, the precaution of giving a new T symbol to him will be taken.

Reference is made to the report of Special Agent Thomas G. Forsyth, III, Pittsburgh, February 19, 1962.

There follows a brief characterization of informants used in referenced report:

- PG T-2 is a New Kensington, Pa., numbers writer, formerly connected with prostitution activities.
- PG T-3 is a physician, whose professional services have, on occasion, been used by members of the MANNARINO organization and who frequents MANNARINO-controlled gambling and after-hours establishments.
- PG T-8 is a New Kensington, Pa., laborer who has considerable employment in the vicinity of GABRIEL MANNARINO's cottage near Leechburg, Pa.
- PG T-11 is a prostitute who is acquainted with many Western Pennsylvania gamblers and racketeers.
- PG T-17 is a gambler who is familiar with gambling and racketeering activities and individuals in the East Liberty section of Pittsburgh, Pa.
- PG T-21 is a Pittsburgh, Pa., businesswoman who frequents places where gamblers and racketeers congregate.

- PG T-24 is an operator of an Allegheny County, Pa., gambling establishment competing with the MANNARINOS.
- PG T-27 is a New Kensington, Pa., professional man who is widely acquainted among the gambling element in that area.
- PG T-30 is a businessman in Allegheny Township, Pa., whose business brings him into contact with many of the people in that area from all walks of life.
- PG T-32 is a former racketeer from Mercer County, Pa.
- PG T-33 is a Pittsburgh, Pa., gambler who associates with racketeers, prostitutes and politicians.
- PG T-34 is a Wilmerding, Pa., native who can gain entrance to all gambling and after-hours places in that region.
- PG T-35 is a student who has worked with racketeers and gamblers in Vandergrift and Oakmont, both Pa.
- PG T-36 is a gambler familiar with activities in the Latrobe-Ligonier, Pa., area.
- PG T-37 is a New Kensington, Pa., working man who is acquainted with numerous gamblers and who frequents after-hours places.
- PG T-38 is an individual whose experience as a bookie in New Kensington, Pa., and surrounding area is of at least 10 years standing.
