AGUERO was interviewed in the New York Office on 5/23/60. The interview lasted approximately three hours and was terminated because of prior commitments by AGUERO. As a result a complete interview was not conducted on this occasion. Accordingly a lead is being set out with this report to have AGUERO reinterviewed to obtain additional information from him as well as to develop him further on the theory that at this time he exhibits a good potential as a possible PSI.

ADMINISTRATIVE CONT'D

On 5/3/60, JON SPELLER advised that he intended to take AGUERO to Washington, D.C., to meet with General CUSHMAN, the Executive Assistant to Vice President NIXON. He said the principal purpose of the visit to Washington would be to attempt to expedite getting AGUERO's family out of Cuba.

During the course of the interview of AGUERO, this particular point was not gone into due to the fact that the interview had to be terminated.
