ReCGairtel to Bu 9/26/68, captioned "Ad Hoc Committee for a Marxist Leninist Party, USA" IS-CH requesting NYO furnish CG pertinent information regarding subject's trip to Europe and advise re any known travel plans of subject during the month of October.

For information of CG, proposed mailing of anonymous letter from Canada to TANG Ming-chao, Vice Chairman, Chinese People's Committee on World Peace, expressing concern of subject's fate of ISRAEL EPSTEIN et al, in attempt to create concern on the part of TANG re her indiscretions and capabilities, as set forth in NYairtel to Bu 8/2/68, copy of which was furnished CG, accomplished by Legat, Ottawa 8/19/68. As indicated by Bu, the operation could work to the advantage of the Ad Hoc Committee (AHC) in the event subject cares to confide in it. (S)

Information from Direction de la Surveillance du Territoire (DST), French domestic counterespionage service, disclosed subject arrived in Paris 8/2/68, and registered at the Hotel Lutetia, 43 Boulevard Raspail, Paris; she departed 8/8/68, without leaving any forwarding address. DST noted subject kept irregular hours in connection with her arrivals and departures from the hotel. (S)
