Your request and the interest that your Service has in this matter have been given our full attention. (S)

The facts that Susan Heiligman Frank was in France and that the S. N. (sic - Securite Nationale /?/ - National Security) was alerted on this same subject (since it is under the jurisdiction of the S. N.) have limited our possibilities of action. Nevertheless, we are happy to be able to forward to you the following information which we have gathered: (S)

- Susan Heiligman Frank, called Susan Warren, seems to be a propagator of People's (Red) China;
- she receives the information bulletin called "Hsin Hua" ("New China") which is published by the agency bearing the same name in London;
- she is a journalist specialized in questions concerning the Far East;

- she lived on the mainland of China from 1960 to 1962;
- as Professor of the Free University of New York, she made many public lectures concerning the Chinese Cultural Revolution and the Red Guards;
- she is in contact with William Howard Hinton, who resides at Fleetwood, Pennsylvania, and who was the subject of your letter V - 4549 dated April 23, 1968;
- among the persons whom Susan Warren intended to visit in Paris were the following individuals:

- ✓ • Helene Marchisio, member of the Franco-Chinese Association of Friendship (Association des Amities Franco-Chinoises), domiciliated at 32 rue (Street) Maurice Ripoché, Paris, 14; FRANCE
- ✓ • Jack Belden, living at the Hotel de Suede, 15 Quai Saint-Michel, Paris, 5; FRANCE
- ✓ • Perdita Huston Champey, American citizen, spouse of a French student of medicine, domiciliated at 3 rue d'Alleray, Paris, 15; and FRANCE
- ✓ • Djeffouli Naceur, living at 52 rue Gay-Lyssac, Paris, 5. FRANCE (S)

Susan Warren stayed at the Hotel Lutetia in Paris from August 2 to August 8, 1968, when she left for London. (S)

✓ In London, she was supposed to visit Al Dhahir, an Iraqi, who lives at 40 Peckarmans Wood, Crescent Wood Road, London SE - 26. ENGLAND (S)
