NYfile 105-81839, captioned "MORTEZA AABDOLLAH, aka; IS-IRAN," Bufile 105-158685 and NKfile 105-20760, apparently identical to AABDOLLAH, supra; NYfile merely sets forth background information re AABDOLLAH and disclosed a questionnaire submitted by him was possibly selected by NAVYHO, an Iranian national who, as a result of information made available by NY 3653-S*, on 8/1/64, was identified as an agent of the KGB New York Residency, as a possible candidate to be returned to Iran sometime in the future, either to assume the leadership of the Tudeh Party or at least to set up the necessary machinery to get the party functioning again

NYO indices contain numerous references to DAVID A. ROBINSON, none of which were identifiable with ROBINSON, supra, based upon information available.
