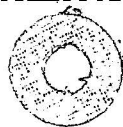

As set out in referenced Paris letter, the photo-
copy of subject's address book, as furnished by the Service
de Documentation Exterieur et de Contre-Espionnage (SDECE),
French foreign intelligence and counterespionage service,
Paris, was forwarded to the Bureau. Paris did not make a copy
of the address book. By referenced Bureau letter, the photo-
copy of the address book was furnished to New York, together
with a translation of the SDECE report (S)

Enclosed for the information of New York is a copy
of referenced London letter, which is self-explanatory.

New York is requested to review the address book
and advise if there are any names and/or addresses in London
and, if so, advise London and Paris. In the event there are
names and addresses in London, Paris will request SDECE
clearance for passage of such data to MI-5. (S)

For the information of the Bureau and recipient
offices, Paris has this date requested of the SDECE clearance
to pass to MI-5 the information that subject, while in London,
planned to visit AL DHAHIR, which was set out in the SDECE
report. (S)
