Susan Heiligman Frank

During September, 1968, a confidential source abroad advised among the people whom Susan Heiligman Frank, also known as Susan Warren, intended to visit while in Paris during August, 1968, were the following: (S)

Helene ~~X~~ Marchisio, a member of the Franco-Chinese Association of Friendship (Association des Amities Franco-Chinoises), who resided at 32 rue Maurice Ripoché, Paris 14. France

Jack ~~X~~ Belden, who resided at the Hotel de Suede, 15 Quai Saint-Michel, Paris 5. France

Perdita Huston ~~X~~ Champey, spouse of a French medical student, who resided at 30 rue d'Alleray, Paris 15. France

Djeffouh ~~X~~ Naceur, who resided at 52 rue Gay-Lyssac, Paris 5. France (S)

While in London, during August, 1968, she was to visit Al ~~X~~ Dhahir, an Iraqi, who resided at 40 Peckarmans Wood, Crescent Wood Road, London S.E. 26. England (S)

At Paris, it is requested those individuals residing in Paris, including the Franco-Chinese Association of Friendship, be identified and any information of a security nature regarding them be obtained. (S)

At London, it is requested Al Dhahir be identified and any information of a security nature regarding him be obtained. (S)
