For information Hong Kong, subject, a pro-Chicom sympathizer, traveled to Paris during 8/68. Her activities in Paris were covered by the Service de Documentation Exterieur et de Contre-Espionnage (SDECE) whose identity should be protected and as a result of this coverage a photocopy of the contents of an address book belonging to subject was furnished Legat, Paris. Among the notes and addresses set forth in this address book was the name David A. Robinson, 3 Sunset Road, Wellesley, Massachusetts.

Enclosed Boston letter sets forth results of investigation conducted to identify Robinson. Hong Kong will note Robinson was born in China and resided in Hong Kong during 1966. Bufiles do not set forth any data identifiable with Robinson.

Hong Kong is instructed to determine through appropriate sources if Robinson came to the attention of these sources in connection with pro-Chicom activities or contacts while in Hong Kong. (c)

Upon receipt of information from Hong Kong, New York should submit its recommendation regarding an interview of Robinson to determine if he is in a position to furnish information regarding subject.
