Subject's name appeared in a photocopy of a notebook of SUSAN H. FRANK, which had been furnished by the Service de Documentation Exterieur et de Contre-Espionnage (S)

For information of Albany, FRANK and her husband, RICHARD C. FRANK, reside at 110 Christopher Street, NYC; both are SI subjects of the NYO.

SUSAN FRANK was reported to be a member of the CP, USA, as late as 1961, and information was obtained indicating CP membership on the part of her husband in 1957. They are known to currently associate with CP members, however, as of 1963, SUSAN FRANK was suspected of being an agent of the Peking Government by a high ranking official of the CP, USA. They are in frequent contact with leaders of the Progressive Labor Party and associate with JAMES and ANN LEE, owners and publishers of the pro-communist newspaper "China Daily News," She has reportedly written articles for "Challenge," the publication of the Progressive Labor Party, under the pseudonym of LISA ARMAND. SUSAN FRANK is also a member of the Students for a Democratic Society.

Records of the Manhattan Board of Elections disclosed subject, born 8/16/44, USA, is described as being 5'4", brown hair, green eyes, and single. She first registered in 1967. At that time she was residing at 50 West 86th Street, NYC, and was employed at the Department of Social Services, NYC.

Records of the Credit Bureau of Greater New York disclosed subject, as of 10/12/67, resided at 236 West 74th Street, NYC, and formerly resided at 50 West 86th Street, NYC. Her employer was listed as the Retail Credit Co., 750 Third Avenue, NYC, and she had been employed at the Syracuse University Library.
