This is the first communication by NY to the Bureau and Newark captioned as above.

ReBulet to NY 10/4/68 entitled, "SUSAN HELLIGMAN FRANK; IS-CH", enclosed [a photocopy of a notebook belonging to FRANK, and which was furnished by the Service de Documentation Exterieur et de Contre-Espionnage.] (S)

It should be noted that SUSAN HELLIGMAN FRANK, a resident of NYC, was visiting in Paris, France, during August, 1968. FRANK, a former CP member, is currently known to be active in the NY area in causes and activities sympathetic to the Red Chinese Government. In this connection, she is in frequent association with people who are of like mind.

A review of the above-mentioned notebook, the contents of which were provided by the aforescribed French Intelligence Agency, disclosed a number of names among which appeared the following: (S)

JOE HELLMANN, 107-23 219th St., Queens Village, NY.  
HO 81513.

The above telephone number, according to the current Queens, NY Telephone Directory is listed to BERNARD HELLMANN, 107-23 219th St., Queens Village, NY. Investigation at New York disclosed that BERNARD HELLMANN is the father of subject.

NYO indices contained no information identifiable with the subject or his father.

Credit and criminal records, which were checked in December, 1968, contained no information identifiable with subject.

On 1/15/69, CSNY 21, who has furnished reliable information in the past, reported that JOSEPH BERNARD HELLMANN, 107-23 219th St., Queens Village, NYC, was born on 11/7/39, in the U.S.A. His father was indicated to be BERNARD HELLMANN, born 9/18/01, and his mother, MARIA, born 12/17/06. As of February, 1964, the source advised that the subject was employed as an Assistant Engineering Research Scientist at New York University. His marital status was described as single.

On 2/5/69, PATRICIA SWETT, Office of the Vice President, Faculty Personnel, NYU, confirmed that subject had been employed as an Assistant Research Scientist at the University's Bronx campus from 12/1/63 to 5/16/66.

On 2/7/69, Mrs. ELIZABETH HARWEG, Recorder at the NYU Graduate School of Engineering, advised that the subject attended NYU as a graduate student from September, 1962 until June, 1963, at which time he received a Master's Degree in Civil Engineering. The records also show he took a course at NYU from September, 1964 to June, 1965, in Meteorology.

The records further show that while attending NYU the subject was employed with the NYC Department of Public Works as a Civil Engineer from June, 1962, to September, 1962, and again from July, 1963 to November, 1963.

NYU records, as furnished by Mrs. HARWEG, show the subject graduated from Bishop Loughlin High School, Brooklyn, in June, 1957, and that he received a Bachelor's Degree in Civil Engineering (BCE) from Cooper Union College, NYC, in 1962.

On 2/13/69, Mrs. VICTORIA KOVER, Registrar's Office, Cooper Union, confirmed that the subject had attended school there from 1957 to 1962, at which latter time he graduated with a BCE degree.
