

The agents who observed subject and her husband, RICHARD C. FRANK, at the office of the "China Daily News", on July 7, 1968, were ROBERT L. PENCE, ROLAND G. KEARNS and EDWIN YEE.

It is noted the enclosed report mentions numerous contacts between subject and IRA GOLLOBIN and JAMES and/or ANN LEE. The substance of the contacts with GOLLOBIN were generally to make appointments to meet either at subject's apartment or elsewhere. The substance of the contacts with the LEEs, principally ANN, was to make an appointment to meet or merely to engage in conversation of a social nature.

There are no Bureau approved characterizations for the Coalition For An Anti-Imperalistic Movement, Veterans and Reservists For Peace in Vietnam or the Youth International Party, mentioned in the report.

A copy of this report is being furnished Chicago for their file captioned "Ad Hoc Committee For A Marxist Leninist Party, IS-CH" Specause of their interest in subject in connection with this matter.





NY T-2, on August 15, 1966, advised RICHARD C. FRANK is a staunch pro-Chinese Communist.

# Travel

Special Agents (SAS) of the Federal Bureau of Investigation (FBI), on May 1, 1968, observed subject and her husband boarding British Overseas Airlines Corporation (BOAC), flight 503, departing John F. Kennedy International Airport, New York, for Nassau.

On April 29, 1968, NY T-3, had advised subject and her husband had reservations at the Hotel Beachview, Nassau.

NY T-4, a confidential source abroad, advised subject arrived in Paris, France, on August 2, 1968, and registered at the Hotel Lutetia, 43 Boulevard Raspail, Paris, where she remained until August 8, 1968, at which time she departed without leaving a forwarding address. Source advised she kept irregular hours in connection with her arrivals and departures from the hotel.(5)

On September 20, 1968, NY T-5, a confidential source abroad, advised subject, also known as, Susan Warren, while in Paris, intended to visit HELENE MARCHISIO, a member of th the Franco-Chinese Association of Friendship (Association des Amities Franco-Chinoises), who resided at 32 rue Maurice Ripoche, Paris; JACK BELDEN, Hotel de Suede, 15 Quai Saint-Michel, Paris; DERDITA HUSTON CHAMPEY, Spouse of a French France medical student, who resided at 3 rue d'Alleray, Paris, and DJEFFOULL MACEUR, 52 rue Gay-Lyssac, Paris, While in London, during August, 1968, she was to visit AL DHAHIR, an Iraqui, at 40 Peckarmans Wood, Crescent Wood Road, London (S) China

Mrs. Soschi Marchisings France Helen Strand NY T-4, on December 5, 1968, advised MARCHISIO, nee LE MONNIER de GOUVILLE, claims to be an economist by occupation and is married to JOSEPH MARCHISIO, a history and geography professor. The MARCHISIOs are known as militant pro-Chinese and members of the Association des Amities Franco-Chinoises (AAFC). JOSEPH MARCHISIO is the treasurer of the AAFC, while his wife handles the secretarial work, They have been in contact with members of the Chinese Communist diplomatic (3) MARCHISIO France

establishment in Paris. During the Summer of 1967, HELENE MARCHISIO travelled to Communist China, as the head of the delegation of AAFC members.(g)

NY T-5, on November 10, 1967, advised the AAFC is controlled by the masterminds of the French Communist Movement (Marxist-Leninist) and had launched a magazine called "Eyes Turned Toward China". (\$7)

Source stated CHAMPEY is a United States (US) citizen, who, until 1960, was employed as a secretary for the Tunisian Secretariat of Information. She subsequently was employed as a medical assistant in Algeria. Reportedly, she is presently employed as a jounalist for "Time" and "Life", Paris.(5)

Source further stated NACEUR DJELLOULI, believed identical to DJEFFOULI, is a Tunisian citizen, and a warehouseman by trade.

JACK ALFRED BELDEN is a US citizen, born February 3, 1910, New York, and is described as a writer, whose residence in the US, was 204 Woolland Avenue, New Jersey. (5)

NY T-6, a confidential source abroad, advised subject arrived in London, on August 8, 1968, and reportedly was to stay at the Cadogan Hotel, London, England, where she remained until August 15, 1968.(5)

Immigration and Naturalization Service (INS), New York City (NYC), advised subject returned to New York, on August 15, 1968.

NY T-3, on July 25, 1968, prior to subject's departure for Paris and London, had advised subject had made inquiry concerning the names of people at the offices of the Students For a Democratic Society (SDS) whom she could confer with about some of the students who might have been involved in the events that occurred in Paris, about a month previous. She indicated she knew some people in Paris, whom she described as being "activists", but desired to be certain she would be able to contact people concerning the events.

Mrs. P. BURKART, Air France (AF), NYC, on December 19, 1968, advised subject and her husband had reservations to depart New York, for Mexico City, via AF, on December 20, 1968.

On the same date Miss S. WEINER, United Travel Service, NYC, advised the FRANKs had reservations at the Hotel Del Paseo, Mexico City, during the period December 18, 1968, to January 16, 1969.

SAS of the FBI, on December 20, 1968, observed the FRANKs boarding AF 017, departing John F. Kennedy International Airport for Mexico City.

INS, Miami, Florida, advised the FRANKs arrived from Mexico, on January 10, 1969; they subsequently departed Miami for New York.

# Political Sympathies of Subject

NY T-6, on March 20, 1968, advised subject, under the name Susan Warren, is in regular receipt of the "Peking Review", from the Chinese Diplomatic Mission in London. (5)

It is noted the "Peking Review" is a magazine published in Peking, China, for dissemination outside China.

NY T-3 advised, on April 1, 1968, subject appeared to be very concerned about an article entitled, "Peking Jails 'Renegade' Westemers", which appeared in the April 1, 1968, issue, of the "New York Post".

The article stated in substance two of Peking's most loyal and durable foreign resident Communist supporters, ISRAEL EPSTEIN, 60 years old editor of "China Reconstructs" and his wife, had been arrested and charged with espionage. Another long-time British renegade resident in Communist China, MICHAEL SHAPIRO, had also been arrested and detained, but not charged with espionage. Most non-diplomatic foreign residents in Peking, no matter how demonstrably and consistently pro-Communist, were trying to flee the capital.
