ReMMlet to Bureau 3/4/69, advising subject and husband, RICHARD ~~C~~ FRANK, arrived at Miami International Airport 1/10/69, via Pan American World Airways (PAWA) Flight 551.

On 2/13/69 ~~MEX-21~~ *(u)* advised the FRANKs arrived at the Hotel Del Paseo, Mexico, D.F., 12/21/68, and departed 1/3/69. While at the hotel they made a long distance telephone call to number 2-00-74, Hotel Los Arcos, Taxco, Mexico, Office of Reservations.

On 5/9/69, HOWARD FINLEY, PAWA, Mexico City (protect by request) advised a review of passenger manifests for PAWA 551, which departed Mexico City 1/10/69, for Miami and Tampa with a stop at Merida, Yucatan, Mexico, failed to disclose anyone named FRANK on the flight. However, he stated if subject boarded the flight at Merida the record would be located in Florida, not Mexico City. *(u)*

~~MEX-21~~ *(u)* on 6/4/69, advised he had been unable to obtain any additional information concerning the activities of subject and her husband in either Taxco or Mexico City.
