**SDECE** in the past had advised subject was in  
possession of a notebook containing the name and address of *(S)*  
DAVID A. ROBINSON, 3 Sunset Road, Wellesley, Massachusetts. *(H)*

On 9/26/69, Mrs. ROBERT WELSH (protect), Trevoze,  
Pennsylvania, advised on that date a Reverend DAVID ROBINSON,  
Wellesley, Massachusetts, had been invited to speak before  
a women's group at the Morrisville Presbyterian Church,  
Morrisville, Pennsylvania. According to WELSH, ROBINSON  
criticized the US policy concerning China, spoke favorably  
of China, and stated the people of the US should write to their  
representatives to advocate the admission of China to the UN.

ROBINSON, who is associated with the Boston Theological  
Institute, Cambridge, Massachusetts, was not interviewed by  
Boston, as it felt the possibility of embarrassment to the  
Bureau outweighed the value of any information gained through  
interview.
