On 4/9/70 British Security Service, MI-5, under a SECRET classification, advised that a secret and reliable source of theirs states that subject is an open advocate of revolutionary violence as the only means of bringing about social change. He intends to remain in England to "radicalize the students". He is said to have considerable private resources and also has access to the funds of the Bertrand Russell Peace Foundation. (S)

[MI-5 states that subject is reported to be a close associate of the American, naturalized British, pro-Communist in London, WILLIAM FRANKLIN ASH (S) Bureau attention is called to London letter dated 11/18/66 (Bufile 100-339235) [which identifies ASH (S);

Also enclosed for the Bureau is a copy of an article dealing with subject which appeared in the 2/25/70 edition of the "London Times".
