Re New York radiogram to Bureau dated 7/9/63.

NK 2366-C advised he returned from Fall River, Massachusetts, 7/9/63, where informant was in contact with (FNU) GUIDO (phonetic) concerning a possible TFIS matter from the Fall River, Massachusetts, area.

During informant's discussion with GUIDO, the latter invited informant to return to the Fall River area on 7/10 or 11/63 and attend a "clam bake" to be held on a small island off the Massachusetts coast. GUIDO allegedly told informant that all the "good people" from the Northeast area would attend. GUIDO also apparently commented that informant could make some good contacts at this meeting. This meeting is suppose to be held on the weekend of the 13th and 14th, the exact time and place not known.

Informant is departing Newark, 7/10/63 for Fall River, Massachusetts, and will allegedly attend this meeting.
