DOCKS RECEIVING CEMENT PRODUCTS, HOWEVER, ZARLENGA WAS IN CHARGE OF THE DOCKS RECEIVING IMPORTED CEMENT IN FALL RIVER AND THAT NEW BEDFORD AND FALL RIVER ARE ADJACENT CITIES IN MASSACHUSETTS.

PATRIARCA WAS CONTEMPLATING CONTACTING THE INDIVIDUAL CONNECTED WITH THE CEMENT DOCKS "IF THEY WERE STILL OKAY WITH HIM" IN ORDER TO ASSIST THE ELECTION OF TED GLEASON AT THE ILA CONVENTION, MIAMI. NOT KNOWN BY THIS INFORMANT IF PATRIARCA EVER DID CONTACT THIS INDIVIDUAL.

NEWARK OFFICE WILL IMMEDIATELY FURNISH BOSTON ALL INFORMATION CONCERNING THE BACKGROUND OF NK 2366-C THAT MIGHT HELP EVALUATE THE INFO. ALSO FURNISH INFORMATION CONCERNING THE TFIS ANGLE MENTIONED IN RETEL.

SOURCES HAVE BEEN ALERTED IN BOSTON AND NO INDICATION OF ANY CONTEMPLATED MEETING. NO PHYSICAL SURVEILLANCE BEING CONDUCTED SO AS NOT TO COMPROMISE THE POSITION OF THE INFORMANT.

IT IS TO BE NOTED THAT THERE ARE HUNDREDS OF ISLANDS OFF THE EAST COAST OF MASSACHUSETTS IN WHICH A CLAMBAKE COULD BE HELD.

NEWARK WILL CONTACT THE INFORMANT UPON HIS RETURN AND OBTAIN ALL INFORMATION CONCERNING THIS CLAMBAKE.
