Re Milwaukee airtel to Bureau 8/12/64 and WFO airtel to Bureau 8/24/64, both concerning JASPER GALLO who allegedly visited this country from Italy on or about August 1, 1964.

On 8/26; 9/8 and 15/64 MI 623-C-TE advised that he had been unable to obtain any additional information concerning the movements of GALLO in this country. He suggested, however, that, in the absence of records on JASPER GALLO, it might be possible to trace GALLO through the Italian equivalent of his first name, i.e., GASPERO GALLO. Informant stated that GALLO and JOSEPH ZITTO of Rockford, Illinois formerly were co-owners of the Pinehurst Dairy in Rockford, Illinois at which time JASPER GALLO was boss of the Rockford family. Informant said that GALLO was married to the sister of JOSEPH ZITTO. After he sold out in Rockford, he returned to Italy to live. Informant did not know whether GALLO was an American or an Italian citizen, but he stated that GALLO served a sentence at Leavenworth Penitentiary for bootlegging perhaps 25 years ago. Description of GALLO previously set out.

Informant also advised on 8/10/64, and Springfield was informed by teletype, that GALLO at that time was said to be visiting TONY ZITTO.

None of the information furnished by MI 623-C-TE pertinent to the movement of GALLO should be set out in details of a report but should be confined to Administrative Pages for the security of this informant.

In view of the fact that all checks to date have produced only negative results, the following additional leads are being set out to identify GALLO and to determine whether he recently visited this country.

LEADSCHICAGO DIVISIONAt Chicago and Rockford, Illinois:

1. Will contact appropriate INS Office and determine whether GASPERO or JASPER GALLO was registered as an alien at any time or whether there is a naturalization file pertaining to him.
2. Will check with pertinent Clerk of U.S. District Court to determine whether GASPERO or JASPER GALLO was naturalized while in Rockford.

WASHINGTON FIELD OFFICE

1. Will check passport records at the Department of State for information on GASPERO GALLO.
2. Will check Central Office of INS, Non-Immigrant Control Indices, for information on recent arrivals (about 8/1/64) of GASPERO GALLO or JASPER GALLO.
