Re Milwaukee airtel to Bureau 8/4/64 concerning postponement of LCN meeting originally scheduled for 8/2/64 at farm of SAM BATTAGLIA, Chicago, Illinois.

MI 623-C-TE was recontacted on 8/10, 26; 9/8 and 15/64 with negative results regarding the proposed meeting. Informant said that he had heard nothing further as to when the meeting would be held, but has no reason to believe that it will not be held. Because the informant has learned nothing locally about the meeting, he has contacted friends in Rockford, Illinois on several occasions with hope of learning new developments, but with negative results. Informant will continue his efforts.

In the meantime, all offices are requested to be alert for movement of Top Echelon La Cosa Nostra members in October but the same security should be maintained regarding the proposed meeting as was previously requested.
