ReBulet to Philadelphia dated 7/24/64 captioned La Cosa Nostra, AR - Conspiracy," instructing Philadelphia to conduct Anti-Racketeering investigations on individuals identified by Philadelphia sources as being members of La Cosa Nostra. Included in this list was GAETANO SCAFIDI.

The Philadelphia Division since February 1964 maintained a dead file to correlate information re captioned individual. GAETANO SCAFIDI was known to be deceased. is the father of PH 672-C-TE (ROCCO SCAFIDI) and SAM SCAFIDI (Phila. file 92-1173).

PH 672-C-TE has indicated GAETANO SCAFIDI has been deceased approximately eight years.
