NOTE: Captioned organization is planning air raid over Cuba. Raid is to take place from Bimini, Bahama Islands. Plane to be used in raid is located at Fort Lauderdale, Florida. Plan is to take plane to Bimini and to have participants and bombs brought to Bimini by boat from Florida. Referenced teletype indicates final practice flight to be made 12/20/63 thus raising good possibility raid may take place this week end. Miami Office has been keeping interested agencies including Gregg Bentley, Special Branch, Bahamas, advised. John Davitt, Internal Security Division, Department, on 12/13/63 advised he had instructed Customs and FAA to take steps to prevent raid and requested we keep USA, Miami, advised of developments. Retel indicates interested agencies and Bentley have been advised but no mention is made that latest information has been given USA. We should be certain that this is
