It is to be noted that this report contains results of interviews conducted by U.S. Customs of CHARLES BUSH, WILLIAM T. SHEARER, ARMANDO MARTINEZ and BERNARD A. FRANK, attorney for DAVID ROE, owner of the EBB TIDE, Jr. Consequently, it is felt that reinterviews of these individuals would be an unnecessary duplication of effort by this office at this time. Also, it is felt that interviews of BUSH, SHEARER, ROE and MARTINEZ would merely serve to make the MIRR more security conscious at a time

MM T-1 is again in an excellent position to furnish valuable information on a current basis concerning these plans providing BOSCH does not invoke additional security measures. It is also felt that the Department of Justice now has ample evidence on which to predicate the prosecutive opinion in this case.

Synopsis: On 12/31/63 FRANK FIORINI, admitted associate of WILLIAM JOHNSON, denied implication in or any specific knowledge of attempted MIRR air raid 12/28/63. U.S. Customs Agency Service, Miami, advised that WILLIAM T. SHEARER, pilot of Piper Aztec N-4811-P, furnished signed statement claiming he flew to Bimini, Bahama Islands, from Fort Lauderdale 12/28/63, upon instructions CHARLES BUSH, to pick up one OTTO J. LEWIS, but was unable to find LEWIS so returned Miami 12/29/63. On 12/30/63 BUSH told Customs he gave flying lessons to Cuban pilot EVELIO ALPIZAR and that he had recent conversations with WILLIAM JOHNSON, but he claimed he sent SHEARER to BIMINI to pick up OTTO J. LEWIS, identity unknown to BUSH, after receiving telephone call from an unidentified person making this request. On 12/30/63, ARMANDO MARTINEZ, owner of a 16' Thunderbird boat, registration #5171-H, advised Customs that on the afternoon of 12/28/63 his wife lent this boat to Dr. ORLANDO BOSCH, who is head of MIRR, for fishing. SHEARER, BUSH and MARTINEZ denied knowledge or implication in attempted MIRR raid 12/28/63. On 1/9/64 BERNARD A. FRANK, attorney for DAVID ROE, advised Customs that he purchased EBB TIDE, Jr. as an adjunct to his used car business, the CMA Sales Company, with understanding his employee, WILLIAM JOHNSON, could also take clients out in boat, but ROE did not authorize JOHNSON to turn boat over to anyone else. seized during 12/28/63 MIRR raid attempt set forth. Dr. ORLANDO BOSCH AVILA gave statement to press claiming that bombs would have been dropped on crowds in Havana celebrating 5th anniversary of the revolution on 1/2/64 had boat not been seized carrying bombs to secret base in Caribbean. MM T-1 has advised that BOSCH gave this distorted statement to press for propaganda purposes as MIRR intended only to bomb oil installations at Nuevitas, Cuba. MM T-1 also advised that BOSCH is presently attempting to raise more money to carry out further bombing raids against Cuba.
