Attached is copy of referenced Department letter dated 3-30-64. Keep Bureau and interested agencies currently advised of all pertinent developments. [Also advise appropriate Bahamian authorities of MIRR plans.] (G-1)(u)

NOTE : MIRR, anti-Castro organization, has carried out several raids against Cuba, the last of which was thwarted by US authorities in December, 1963. Referenced Department letter, which was in response to our request for prosecutive opinion concerning the December, 1963, raid, stated that Department wdidd not contemplate initiating criminal action at this time. XInformation has now been received indicating MIRR is planning new raids against Cuba from Andros Island in the Bahamas. One raid allegedly will be by boat : against Soviet freighter off Florida coast and another will be by air over sugar areas in (Cuba. Our informant in this matter is Cuban refuge pilottwho has furnished information on the statwo previous occasions which has lead to the thwarting of these raids. Previous investigation has reflected that the MIRR is an anti-Castro organization of Cuban exiles headquartered in Miami under the leadership of Dr. Orlando Hosch Avila. The MIRR has claimed credit for several airplane bombing raids over Cuba in 1963. Their last attempt was stopped when the f(c, t)U. S. Customs and U. S. Coast Guard seized two boats, explosives, and a plane on December 28, 1963, in the Miami area.

In January and February, 1964, Dr. Bosch began making plans for further raids, but encountered difficulty in raising sufficient funds with which to carry out his plans.

Current Developments

On March 25 and 26, 1964, MM T-1, a Cuban exile who is friendly to some of Bosch's close associates, advised that Bosch's plans have recently undergone some revision and acceleration. Bosch intends to set up a base of operations on Andros Island in the Bahamas. He will rent a boat in the Miami area and transport a quantity of arms and explosives from Miami to Andros Island where these materials will be cached. On this trip he will attempt to choose a suitable air strip to accommodate an Aerocomander plane. On this

Thereafter, the plane will be used to bomb sugar centrals in Cuba, taking off from Andros, but returning to Florida after each raid. $\bigotimes (1)$

Bosch also will use one or more small boats to attack a Russian freighter off the coast of Florida. These attacks will be launched from Andros Island. & KY4,

MM T-1 stated no dates have been set for establishing the base on Andros Island, or for attacking any of the targets. Bosch has not yet acquired a plane.

MM T-1 said the MIRE, under the direction of Bosch, is now cooperating with the Comandos L, which is an anti-Castro action group under the leadership of Antonio Cuesta and Ramon Font, both of Miami. 2(2)(4)

Bosch has disclosed that Comandos L has made plans for a boat raid against shipping off the north coast of Cuba near Camaguey Province. Comandos L is monitoring marine radio messages involving merchant vessels proceeding south off the coast of Florida toward Cuba. MM T-1 said that one of Bosch's men, Orlando Ramirez, an explosives expert, is preparing the explosive materials to \mathcal{F}_{lin} be used by Comandos L.
