UNDER 24 HOUR DAILY SURVEILLANCE. CUSTOMS HAS IDENTIFIED ORLANDO  
RAMIREZ, MIRR BOMB EXPERT, AS ONE OF TWO MEN OBSERVED ON BOARD  
BOAT.

ON MAY 14 LAST [REDACTED] PROTECT, ADVISED  
THAT LAREDO RODRIGUEZ, TREASURER OF MIRR, WHO IS NOW INSTRUCTING  
[REDACTED] DAILY RE-INSTANT PLOT, HAS DISCLOSED THAT A FLOATING  
EXPLOSIVE MINE HAS BEEN TRANSPORTED TO PALM BEACH AND WILL BE  
PLANTED BY THE BERTRAM SPEEDBOAT IN DIRECT PATH OF THE "LAS VILLAS"  
WHEN IT ARRIVES OFF SOUTH FLORIDA COAST. THIS CHANGE IN PLANS  
WAS NECESSITATED AS RESULT SEIZURE OF HOME MADE TORPEDO BY CUSTOMS  
MAY 12 LAST.

[REDACTED] CONTINUING FLIGHTS TO LOCATE "LAS VILLAS" BUT IT  
IS ANTICIPATED THESE FLIGHTS MAY BE DISCONTINUED MAY 16 OR 17  
NEXT SINCE MIRR HAS RECEIVED INFORMATION REFLECTING "LAS VILLAS"  
WILL NOT ARRIVE UNTIL LATER NEXT WEEK.

CUSTOMS HAS ADVISED THAT THE "LAS VILLAS" DEPARTED MARSEILLES, FRANCE MAY 4 AND PASSED ROCK OF GIBRALTAR MAY 9 DESTINED DIRECTLY TO HAVANA. CUSTOMS ANTICIPATES "LAS VILLAS" WILL ARRIVE OFF FLORIDA COAST ABOUT MAY 22 NEXT.

[ ] ADVISED THAT MIRRLIS DETERMINED TO ACCOMPLISH A STRIKE AGAINST THE "LAS VILLAS" DESPITE SETBACKS.

MIAMI CONTINUING CLOSE CONTACT WITH [ ] AND CLOSE LIAISON WITH CUSTOMS.

BUREAU REQUESTED AFFORD [ ] MAXIMUM PROTECTION.
