On August 13, 1965, a representative of the Central Intelligence Agency, Miami, Florida, furnished our Miami Office information which originated with an unidentified law enforcement officer to the effect that on August 10, 1965, Orlando Bosch Avila, head of the MIRR, was making plans to sink an unidentified merchant vessel which is reportedly scheduled to arrive in Jacksonville, Florida, on August 24 or 25, 1965. Reportedly, Bosch plans to have someone attach a "limpet" mine to the merchant vessel. It was further reported that Augusto Valdes Miranda, also known as "Polo," a Cuban refugee, might be involved in this plot to the extent of permitting Bosch to use his boat bearing Registration Number FL-8477-F in conjunction with the assignment. On August 16, 1965, a Central Intelligence SEE REVERSE Agency representative advised that his Agency has no interest SIDE NOR CLASSIFICATION this matter and possesses no additional pertinent details.
