CIA HAS NO OBJECTION TO DECLASSIFICATION OF THIS INFORMATION IN THIS DOCUMENT

Re Salt Lake City let 5/9/66 with enclosure. It is noted that only two copies of relet and two copies of the enclosure were received at the Bureau.

A copy of the enclosure was furnished CIA via liaison channels.

In view of the information in the enclosure indicating that the subject's brother was a member of CIA in Cuba and in view of the information indicating that the subject's brother was paid \$225 a month by CIA, this matter was discussed with CIA. CIA on 5/31/66 advised that it had no operational interest in the subject or in the subject's brother, Enrique Casuso, Jr. This is for the confidential information of the recipients and must not be included in any material prepared for dissemination.

For your information, the Bureau intends to disseminate the results of the interview to a number of interested agencies, including the RCMP. In order to preclude any unnecessary inferences and since CIA has denied operational interest in the subject and his brother, Bureau feels that the references to CIA in the enclosure should be deleted. Salt Lake City is therefore requested to resubmit the enclosure to relet deleting any references to CIA or CIA activities involving the subject or his brother.
