A copy of the enclosure was furnished CIA via Zliaison channels. In view of the information in the enclosure indicating that the subject's brother was a member of CIA in Cuba and in view of the information indicating that the subject's brother was paid \$225 a month by CIA, this matter was discussed with CIA.
