formerly a high official of the MRR in Cuba, but now in the United States does not get along with MRR leadership in Miami.

On August 30, 1962, [redacted] 119 N. W. 48th Place, Miami, Florida, advised that he is a member of the MRR and a member of the CRC. [redacted] said the underground movement in Cuba is no longer effective, cannot operate, and at the present time could be considered non-existent. [redacted] claimed there are about 100 MRR members in Puerto Rico that are loyal to the leadership of ROBERTO ROCA in Puerto Rico and that ROCA looks to [redacted] for leadership and representation to the CRC. [redacted] explained that although the membership in Puerto Rico is restless and anxious for some military action against Cuba, they have no immediate military plans because they lack sufficient money, weapons, and transportation to effect a military operation.

OTHER 4

[redacted] continued in his charges against the leadership of JOSE IGNACIO LASAGA and CESAR BARO ESTEVA, MRR leaders in the United States. [redacted] claimed that BARO wants to integrate the Roman Catholic Church with any new government of Cuba and make the Roman Catholic religion mandatory instructions for small children in Cuba. [redacted] maintains that the MRR in Miami is dominated by an elite few and the leadership is not representative of the organization. [redacted] claimed there is great dissension, dissatisfaction, and factionalism in the MRR in Miami because of the leadership of LASAGA and BARO.
