The Bureau has revised that page in the enclosures which contains narrative information concerning the ESA. Mexico City is authorized to furnish copies of the photographs and descriptions contained in the enclosures to the Mexican Federal Security Police. It is suggested that the photographs furnished the police be the actual photographs rather than the Xerox copies. (C) (u)
